FIT Payment rates for installations have been determined by the Gas and Electricity Markets Authority (Ofgem) under Article 13 of the Feed-in Tariffs (Specified Maximum Capacity and Functions) Order 2012, in accordance with Annexes 2-4 to the Standard Licence Conditions. Where relevant the rates above have been adjusted by the annual Retail Price Index (RPI) rate of 1.6 percent as of December 2014.

All tariff rates are displayed in pence per kilowatt hour (p/kWh) at 2015/16 values.

Having due regard to Part 2 of Annex 4 of the Modifications to Feed-in Tariffs: Modifications to the Standard Conditions of Electricity Supply Licences (No. 4 of 2012) the FIT Payment rates above have been determined by the Gas and Electricity Markets Authority (Ofgem) in accordance with article 16 of the Feed-in Tariffs (Specified Maximum Capacity and Functions) Order 2012. Please note that the definition of 'stand-alone' has been amended to take effect from 1 May 2013 – please see Annex 3 to the Modifications to the Standard Licence Conditions for the updated definition for relevant tariffs.
