Consent given by the Gas and Electricity Markets Authority pursuant to Standard Condition 9 (Claims for Last Resort Supply Payment) of the Gas Supply Licence granted or treated as granted under section 7A of the Gas Act 1986 to ScottishPower Energy Retail Limited.

## To: ScottishPower Energy Retail Limited (SC190287)

## Whereas:

- A. ScottishPower Energy Retail Limited (the "Licensee") is the holder of a gas supply licence (the "Licence") granted or treated as granted under section 7(A)(1) of the Gas Act 1986.
- B. The Gas and Electricity Markets Authority (the "Authority") issued the Licensee with a direction to supply gas to the customers of Daisy Energy Supply Limited (which traded under the name of "Yorkshire Energy") with effect on and from 6 December 2020 under paragraph 1 of standard condition 8 of the License (the "Last Resort Supply Direction").
- C. The Licensee gave notice to the Authority on 29 October 2021, of its claim<sup>1</sup> for a payment to compensate for any additional costs it incurred in complying with a Last Resort Supply Direction (a "Last Resort Supply Payment") under standard condition 9.3 of the Licence.
- D. Standard conditions 9.5 and 9.6 of the Licence state that the Authority will give its consent for the Licensee to make the claim notified to it if it considers it appropriate in all the circumstances of the case or the Authority may determine that an amount other than the one calculated by the Licensee is a more accurate calculation of the relevant amount for the Last Resort Supply Payment.
- E. The Authority consulted on its determination of the amount it considered appropriate for the Licensee to recover.
- F. The Authority has made a final decision on the relevant amount it will consent for the Licensee to recover as a Last Resort Supply Payment, taking into account representations from interested parties. The reasons for the Authority's decision can be found in its decision document.<sup>2</sup>

## Therefore:

- G. Pursuant to standard condition 9.6 of the Licence, the Authority hereby consents for the Licensee to claim for a Last Resort Supply Payment of up to £1,083,182.39 from the relevant gas transporters. Pursuant to standard condition 9 of the Licence, relevant gas transporters are gas transporter licensees in whose transportation areas there were premises supplied under the Last Resort Supply Direction, excluding independent gas transporters. This amount shall be reduced by 45% of any amounts the Licensee recovers from the liquidation of Daisy Energy Supply Limited.
- H. This consent shall take effect on and from 17 December 2021.
