

## FINAL REPAYMENT DIRECTION

THIS FINAL REPAYMENT DIRECTION is made under clause 7 of the Deed of Undertaking made on 8 February 2022.

between the GAS AND ELECTRICITY MARKETS AUTHORITY (the Authority) acting by THE OFFICE OF GAS AND ELECTRICITY MARKETS (Ofgem) and SHELL ENERGY RETAIL LIMITED (the True-up Agreement).

1. In accordance with its obligations under clause 5 of the True-up Agreement **Shell Energy Retail Limited** (Company Number: **05070887**) has submitted to the Authority a True-up in relation to acting as Supplier of Last Resort (SoLR) to customers of the former **Green Supplier Limited** (Company Number: **11042716**).
2. The Authority has reviewed the True-up in accordance with clause 5 of the True-up Agreement and has determined that the Valid True-up Amount is an Excess. The reasons for the Authority's decision can be found in its decision document published on 14 December 2023.<sup>1</sup>
3. The Authority provided a draft of this Repayment Direction to Shell Energy Retail Limited in accordance with clause 7.1 of the True-up Agreement and has considered representations and responses in accordance with clause 7.2.
4. In accordance with clause 7 of the True-up Agreement the Authority directs that the Excess, including interest accrued, shall be repaid as follows:
  - a. Amount: Excess of **£2,796,448.67**. is to be paid at the time and by the method below.
  - b. Interest: Interest of **£78,771.40**. has accrued in respect of the Excess and is to be paid at the same time and by the same method as the Excess.
  - c. Method: One payment of combined Excess and interest is to be made to each relevant network operator as set out in clause 6 of this Direction.
  - d. Time: by 2 April 2024.
5. The total amount of Excess and interest to be paid by Shell Energy Retail Limited is **£2,875,220.07**.
6. Repayment is to be made to the relevant gas transporter licensees, as set out in Schedule 1, and the relevant electricity distribution licensees, as set out in Schedule 2, in the following amounts:
  - a. **45%** of the total amount be repaid by Shell Energy Retail Limited **£1,293,849.03** is to be paid to each relevant gas transporter licensee in the proportions set out in Schedule 1;
  - b. **55%** of the total amount be repaid by Shell Energy Retail Limited **£1,581,371.04**. is to be paid to each relevant electricity distribution licensee in the proportions set out in Schedule 2.
