#### 3. CEO Report

The Board noted the CEO report, with particular interest in the updates on the policy regime of the Accelerated Strategic Transmission Investment (ASTI) framework, the Connections policy review, and recently published supplier level data.

### 4. Consumer bills to 2035: scenarios and distributional analysis

The Board discussed the Consumer bill to 2035 scenarios including the analysis on the electric vehicle (EV) uptake and net zero investment impact on consumer bills, and how to use this analysis to influence policy decisions.

### 5. Emerging Areas of Flexibility Regulation – SSES and LDES

The Board noted the paper on emerging areas of flexibility regulation, including expanding Ofgem's responsibilities for regulating Long Duration Electricity Storage and how Ofgem should regulate Smart and Secure Energy Systems.

The Board approved the proposal that Ofgem should take on the role as regulator for LDES if asked, subject to resourcing.

#### 6. Internal Audit Plan

The Board noted the paper and approved the Internal Audit plan for 2024/25.

#### 7. Salesforce Licenses and Implementation Partner

The Board noted the update and approved the appointment of a single supplier to be the Service Integration partner for CRM and the appointment of a supplier to be the reseller of software licenses for Salesforce.
