## NOTICE UNDER \$11 OF THE ELECTRICITY ACT 1989 (as amended)

The Gas and Electricity Markets Authority ("the Authority") hereby gives notice pursuant to section 11 of the Electricity Act 1989 (as amended) ("the Act") as follows:

- 1. The Authority proposes to modify the conditions of the distribution licences treated as granted to each of Aquila Networks plc and East Midlands Electricity Distribution plc ("the licensees") under section 6(1)(c) of the Act by modifying special condition B in each licence in respect of the formula in paragraph 1.
- 2. The reason that the Authority proposes to make the above licence modifications is to ensure, pursuant to the Authority's policy statement "Mergers in the Electricity Distribution Sector" issued in May 2002, that customers of the merged group are compensated for the detriment arising from the impact of the merger on the efficacy of comparative price regulation as a result of Powergen UK plc's acquisition of Aquila Sterling Limited, which indirectly owns Midlands Electricity plc. The licensees are members of the merged group.
- 3. In summary, the effect of the proposed licence modifications is that the regulated revenue of the distribution companies in the merged group will in aggregate be reduced by a total of £32 million over a five year period with effect from April 1<sup>st</sup> 2004.

## MODIFICATION TO THE ELECTRICITY DISTRIBUTION LICENCE OF AQUILA NETWORKS PLC AND EAST MIDLANDS DISTRIBUTION PLC

## **SCHEDULE**

1. The formula in paragraph 1 of special condition B (Restriction of distribution charges) shall be amended to read as follows:

$$M_{dt} = P_{dt} + PN_{dt} + LF_{dt} + Q_{dt} + Z_{dt} + CA_{dt} + SW_{dt} - PM_{dt} - MG_{dt} - K_{dt}$$

2. In special condition B (Restriction of distribution charges), the following new paragraph 8 shall be inserted after paragraph 7:

## Formula for MGdt as used in Paragraph 1

8. For the purposes of paragraph 1, in the fifteenth and every subsequent relevant year up to and including the nineteenth relevant year MGdt shall be derived from the following formula, for every relevant year thereafter it shall take the value zero:

$$MG_{dt} = \frac{MR_{dt}.PIM_t}{D_t}$$

where:

MRdt

shall take the value of £3.124 million for Aquila Networks plc and £3.276 million for East Midlands

Electricity Distribution plc

PIM<sub>t</sub>

in the year commencing 1<sup>st</sup> April 2001 equals 1 and in all subsequent years is derived using the following formula:

$$PIM_{t} = \left(1 + \frac{RPI_{t}}{100}\right) PIM_{t-1}$$
