## Notice under section 23 (3) of the Gas Act 1986

The Gas and Electricity Markets Authority (the "Authority") hereby gives notice pursuant to section 23(3) of the Gas Act 1986 (the "Act") as follows:

- 1. The Authority proposes to modify the conditions of the gas transporter licence treated as granted to National Grid Gas plc ("NGG") in respect of its National Transmission System ("NTS") under section 7 of the Act by removing Table A2: *Initial NTS SO baseline entry capacity (GWh/day)* from Schedule A: *NTS output measures for the price control* and replacing this table with the table set out in the Appendix to this Notice.
- 2. The Authority proposes to make this licence modification within the context of implementing the revised transmission price control for NGG with effect from 1 April 2007 as set out in the document "Transmission Price Control Review: Final Proposals, Decision Document, 4 December 2006, Ref: 206/06". This document is available free of charge from the Ofgem Research and Information Centre, 9 Millbank, London SW1P 3GE or from the Ofgem website at www.ofgem.gov.uk.
- 3. The Authority has consulted informally on two occasions setting out draft licence modifications it considers necessary to give full effect to the proposed revised transmission price controls. During this consultation process, the Authority has received several comments and responses from NGG and other interested parties which have identified the need for further refinement of the proposed licence modifications before they can be formally implemented.
- 4. In the light of these comments, the Authority proposes to implement the transmission price control review final proposals in two stages:
  - (a) the first stage involves bringing forward a proposed licence modification which is deemed necessary to roll forward the current regulatory and commercial regime beyond 31 March 2007; and
  - (b) the second stage involves a further statutory consultation on further proposed licence modifications which are considered necessary to give full effect to the transmission price control review final proposals, which the Authority proposes will be applied with retrospective effect from 06:00 hours on 1 April 2007.
- 5. This Notice represents the first stage in the process outline above.
- 6. In summary the effect of the proposed licence modification is to introduce NTS SO baseline entry capacity (GWh/day) values for the formula year commencing 1 April 2007, which are necessary for the continued operation of the regulatory and commercial regime.
