# Notice of revocation of Gas shipper licence


#### Whereas

- A. BHP Billiton Petroleum Great Britain Limited (company registration number 00810819) having its registered office at Company Secretariat, Neathouse Place, London, SW1V 1BH, Great Britain is the holder of a licence (the licence) treated as granted under section 7A(2) of the Gas Act 1986 (the Act) to it on 22<sup>nd</sup> July 1997.
- B. Section 7B(3) of the Act provides that a licence granted or treated as granted under the Act may be revoked in accordance with any term contained in it. Paragraph 1(e)(ii) of Schedule 2 of the Licence provides that the Gas and Electricity Markets Authority ("the Authority"), may at any time revoke the licence on giving 30 days' notice to BHP Billiton Petroleum Great Britain Limited; where it has not commenced business as a gas shipper within a period of 3 years from the date on which the licence came into effect.
- C. By an email dated 20<sup>th</sup> September 2010 the Authority confirmed to BHP Billiton Petroleum Great Britain Limited, that having failed to provide satisfactory evidence that the licensable activity would commence the licence would be revoked.

### Notice of Revocation

The Authority hereby gives notice that with effect from 10<sup>th</sup> November 2010 the licence shall be revoked.

## NOTICE PURSUANT TO SECTION 38A(1)(a) OF THE GAS ACT 1986

Reasons for the decision of the Gas and Electricity Markets Authority revoking the Gas Shipper Licence treated as granted under section 7A(2) of the Gas Act 1986 to BHP Billiton Petroleum Great Britain Limited

The Gas and Electricity Markets Authority ("the Authority") will revoke the Gas Shipper Licence held by BHP Billiton Petroleum Great Britain Limited ("the Licence") treated as granted on 22<sup>nd</sup> July 1997 under section 7A(2) of the Gas Act 1986.

### **Decision**

The Authority will revoke the Licence on 10<sup>th</sup> November 2010.
