#### Decision on changes to the regulatory instructions and guidance described by Amended Standard Condition E12 – D1 of the offshore transmission licence

On 22 February 2013 we published an open consultation letter outlining our proposed modifications to the existing regulatory instructions and guidance (RIGs)<sup>1</sup>. This open consultation letter<sup>2</sup> set out the proposed modifications, the reasons for these modifications, specified that any representations should be made within 30 days (that is, on or before 25 March 2013) and said that the updated RIGs will be applicable to the regulatory reporting for the period from 1 April 2012 to 31 March 2013. This letter contains the decision of that consultation.

The changes that have been consulted on are purely intended to enhance the clarity of the existing reporting requirements therefore we do not believe the timing of these changes will make complying with the requirements difficult. The proposed modifications are summarised in Appendix 1 of this letter.

#### Representations and our decision

We did not receive any responses to our consultation on proposed changes to the RIGs.

We have made the modifications proposed to the RIGs as set out in the Appendix 1 of this letter and Appendix 1 of the consultation open letter. The reasons are contained in the consultation open letter and summarised in the Direction to modify the RIGs issued under Amended Standard Condition E12- D1 of the offshore transmission licences of TC Robin Rigg OFTO Limited, TC Gunfleet Sands OFTO Limited, TC Barrow OFTO Limited, TC Ormonde OFTO Limited, Blue Transmission Walney 1 Limited and Blue Transmission Walney 2 Limited.

We have published the modified RIGs alongside this letter and Direction. The effective date for the modifications to the RIGs is 29 April 2013.
