Proposed modifications to the electricity transmission licences held by TC Robin Rigg OFTO Limited, TC Gunfleet Sands OFTO Limited, TC Barrow OFTO Limited, TC Ormonde OFTO Limited, Blue Transmission Walney 1 Limited and Blue Transmission Walney 2 Limited.

We have today published proposals to modify amended standard licence conditions A1 (Definitions and Interpretation), E12 (amended standard conditions) and E13 (System Operator – Transmission Owner Code) of the electricity transmission licences held by:

- 1. TC Robin Rigg OFTO Limited
- 2. TC Gunfleet Sands OFTO Limited
- 3. TC Barrow OFTO Limited
- 4. TC Ormonde OFTO Limited
- 5. Blue Transmission Walney 1 Limited
- 6. Blue Transmission Walney 2 Limited

The modifications we are proposing and the reasoning behind them are set out in more detail in the notices published alongside this letter and in the consultation published on 4 April 2013¹. A summary of the proposed modifications is provided in the table overleaf.

One response was received to the consultation from Transmission Capital Partners (TCP). TCP highlighted that a different alteration to the calculation of the Transmission System Availability Payment (TSAP $_t$) would be required for TC Barrrow OFTO Limited. This amendment has been proposed in notice under section 11A(2) of the Electricity Act 1989 for TC Barrow OFTO Limited which is published alongside this letter.

Representations or objections to the proposed licence modifications must be made in writing to Hannah Evans on or before 19 July 2013.
